PLEASE NOTE THE FOLLOWING SECTIONS HAVE BEEN UPDATED: 1, 5, 6, 17

1. **SPONSOR & SWEEPSTAKES PERIOD:** The Scotts Live Your Best Lawn Sweepstakes (the “**Sweepstakes**”) is sponsored by Scotts Canada Ltd., 2000 Argentia Road, Plaza 2, Suite 300, Mississauga, ON L5N 1V8 (“**Sponsor**”). The Sweepstakes commences at 12:00:00 AM Eastern Time (“**ET**”) on March 2, 2020, and will end at 11:59:59 PM ET on July 26, 2020 (the “**Sweepstakes Period**”). All times are Eastern Times.
2. **RULES.** By entering this Sweepstakes, entrants agree to abide by these Sweepstakes rules and regulations (the “**Official Rules**”). The decisions of the independent Sweepstakes organization with respect to all aspects of the Sweepstakes are final.
3. **ELIGIBILITY:** To enter the Sweepstakes and be eligible to win a Prize (see rule 6), a person (“**Entrant**”) must, at the time of entry, be a legal resident of Canada who has reached the age of majority in his/her province or territory of residence. The Sweepstakes Parties will not be responsible for late, lost, illegible, falsified, damaged, misdirected, mutilated, garbled, postage due or incomplete entries, which will be void. 6. **PRIZES:** There are twenty one (21) prizes (each referred to as a “**Prize**”) available to be won which are as follows:

Gift cards are subject to applicable details, terms and restrictions. Limit of one (1) Weekly Prize per person. The aggregate approximate retail value (“**ARV**”) of the Prize is \$5,250.00 (CDN).

Any litigation respecting the awarding of a prize may be submitted to the board only for the purpose of helping the parties reach a settlement. Any applicable decision to be made by the Sweepstakes Sponsors affecting the conduct of this Sweepstakes are subject to a ruling of the Régie des alcools, des courses et des jeux.
14. The Sponsor reserves the right to terminate or suspend this Sweepstakes or to amend the Official Rules at any time and in any way, without prior notice or liability, for any reason whatsoever. Without limiting the foregoing, if for any reason the Sweepstakes is not capable of running as originally planned, for example as a result of tampering or infection by computer virus, the Sponsor reserves the right to terminate the Sweepstakes.

In the event of any discrepancy or inconsistency between the terms and conditions of these Official Rules and disclosures or other statements contained in any Sweepstakes-related materials, including, but not limited to point of sale, print or online advertising, the terms and conditions of these Official Rules shall prevail, govern and control to the fullest extent permitted by law.
